The Employment Act covers all employees whose wages do not exceed RM1,500 per month whereas the Sabah and Sarawak Labour Ordinances cover all employees whose wages do not exceed RM2,500 per month. A crane operator earning RM2,000 per month is covered under the Employment Act.
